

Our Protecting Wildlands Program focuses on preserving large blocks of forest and sagelands as the cornerstone of ecological resilience. The protection of landscape-scale wildlands ensures the preservation of core habitat that is essential for the long-term survival and recovery of imperiled wildlife. In the past year, we advised on work to be done under the Department of Natural Resources' new 20-Year Forest Health Plan, advocated for science-based forest restoration on public lands to restore forest health, improve wildlife habitats, and better protect communities from fire. We also secured funding to permanently protect Blanchard Mountain.

4b (Code:) (Expenses \$ 462,311. including grants of \$ 169,995.) (Revenue \$ 378,677.) Habitat Connectivity

The Connecting Habitat Program has always been a cornerstone of our work. We've successfully protected vital wildlife corridors and reconnected habitat between Washington's North Cascades and mountain wildlands to its northwest, northeast, and south, We gained an easement on a key property aside a needed wildlife underpass between the Cascades and Kettle Mountains. We restored habitat and fostered construction of a signature I-90 wildlife overpass between the North and South Cascades. And we won gates on major forest roads in British Columbia's coastal ranges, protecting sensitive grizzly bear habitat from motorized access. We also improved a website that allows

With our Restoring Wildlife Program, we champion the return of key animal species while building greater social tolerance to safeguard their long-term recovery. This past year, we served as a member of Washington's Wolf Advisory Group and participated in the collaborative process to update our state's Protocol for Wolf-Livestock Interactions. Our direct engagement with ranchers in wolf country has helped keep conflict between wolves and livestock to a minimum. This year also saw the first confirmed fisher reproduction since we reintroduced this extirpated species into the South Cascades, signaling healthy forests, grasslands and watersheds that are a result of our continued work to
